You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type

This product is a bearer bond issued under German law.

Term

The product has a fixed lifetime and will be due on the Redemption Date.

Objectives

Objective of the product is to provide you with a specified entitlement according to predefined conditions.

The possibilities for the redemption of the product are as follows:

- (i) If the Reference Price is at or above the Cap you will receive on the Redemption Date the Maximum Amount.
- (ii) If the Reference Price is below the Cap, you will receive the Underlying in the integral number determined by the Multiplier. In addition, you will receive a compensation payment equivalent to the fractional number of the Underlying multiplied by the Reference Price. You will make a loss in case the sum of the value of the delivered Underlying on the Redemption Date and the compensation payment is below the purchase price of the product

You renounce the entitlement to a dividend from the Underlying and you have no right to any further entitlement resulting from the Underlying (e.g. voting rights).



The Issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. 2. What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class.

This rates the potential losses from future performance at a medium-high level, and poor market conditions are very unlikely to impact our capacity to pay you.

In the case of the physical delivery of the Underlying price losses may arise even after the Valuation Date until the Underlying is credited to your securities account.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

3. What happens if XY Bank is unable to pay out?

You are exposed to the risk that the Issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. Thereby the resolution authority has extensive intervention powers. 5. How long should I hold it and can I take money out early?

If you should sell the product before the end of the recommended holding period, the amount you will receive could be – even significantly – lower than the amount you would have otherwise received.
