

# Key Information Document ("KID")

## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

**You are about to purchase a product that is not simple and may be difficult to understand.**

## 1. What is this product?

### Type

This product is a bearer bond issued under German law.

### Term

The product has a fixed lifetime and will be due on the Redemption Date, subject to an early redemption.

### Objectives

Objective of the product is to provide you with a specified entitlement according to predefined conditions. You may receive a Bonus Payment on a Bonus Payment Date if the Reference Price is below the Redemption Threshold on the relevant Observation Date (excluding the last Observation Date) or with respect to the last Bonus Payment Date if the Reference Price is below the Strike Price and above the Barrier on the last Observation Date. The Bonus Payments are calculated based on the product of the Calculation Amount and the Interest Rate per annum. You may not receive a Bonus Payment on a Bonus Payment Date if the product will be repaid prematurely. The product may be repaid prematurely during its lifetime on an Early Redemption Date if the Reference Price is at or above the Redemption Threshold on an Observation Date (excluding the last Observation Date). In this case you will receive the Redemption Payment assigned to the relevant Observation Date. The Redemption Payments rise from one Observation Date to the next.

If the product has not been prematurely repaid, the possibilities for the redemption of the product are as follows:

- (i) If the Reference Price on the Valuation Date is at or above the Strike Price you will receive on the Redemption Date the Redemption Payment assigned to the last Observation Date.
- (ii) If the Reference Price on the Valuation Date is above the Barrier, but below the Strike Price you will receive the Calculation Amount.
- (iii) If the Reference Price on the Valuation Date is at or below the Barrier, you will receive a Redemption Amount which is equivalent to the product of the Calculation Amount and the Reference Price on the Valuation Date divided by the Strike Price. In this case, you will make a loss in case the sum of the Redemption Amount and the accrued Bonus Payments you received over the lifetime is below the purchase price of the product.

You renounce the entitlement to a dividend from the components of the Underlying and you have no right to any further entitlement resulting from the components of the Underlying (e.g. voting rights).

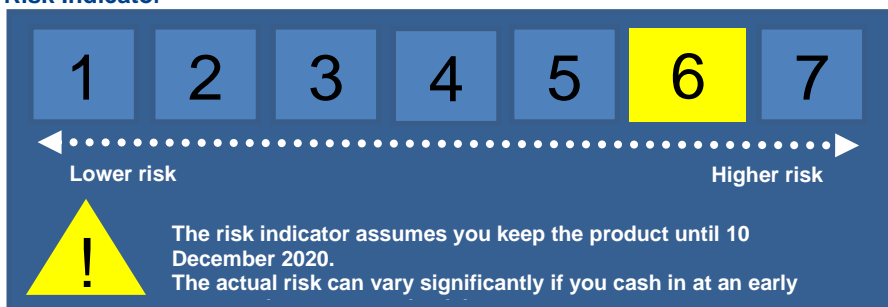
The Issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. **2. What are the risks and what could I get in return?**

**Risk Indicator**

### 3. What happens if XY Bank is unable to pay out?

You are exposed to the risk that the Issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. Thereby the resolution authority has extensive intervention powers. Among other things, it can reduce rights of the investors to zero, terminate the product or convert it into shares of the Issuer and suspend rights of the investors. A total loss of your capital invested is possible. The product is a debt instrument and as such is not covered by any deposit protection scheme.

#### Costs over time

### 5. How long should I hold it and can I take money out early?

#### Recommended holding period: until 10 December 2020 (maturity)

The objective of the product is to provide you with the entitlement described under "1. What is this product?" above provided that the product is held until maturity.

There are no possibilities to take your money out early other than to sell the product through the exchange where the product is listed or off-exchange. If you should sell the product before the end of the recommended holding period, the amount you will receive could be – even significantly – lower than the amount you would have otherwise received.
